Year 12 Technical Examinations Tuesday, 9 until Friday, 12 January 2024

Your child will be involved in examinations during the dates stated above.

Students will be attending their normal timetabled lessons during this period unless they are in examinations. If your child has a morning examination, they need to be outside the exam room at 8:45am. If they have an afternoon examination, this will commence at 1:00pm and your child will need to have lunch at 12:20pm and will need to be ready by 12:45pm outside the exam room. They will be dismissed from the examination room to either go straight to their afternoon lessons.

Students can view their individual timetables online via Edulink. It is important for students to understand that it is their responsibility to know when they have examinations and where they need to be in order to sit those examinations.
